

## Program Category

Program categories will be a useful tool in the program evaluation process. This field will allow TJJD to distinguish between programs with the same program type to compare programs with similar goals. For instance, a substance abuse treatment program designed for a first-time offender with a low-level possession charge will likely have a lower recidivism rate than a program designed for a long-term substance abuser who is also a chronic offender. Because these programs seek to serve different populations through different activities, it would be inaccurate to compare their recidivism rates.

Program categories assist TJJD in grouping programs based on numerous variables, including, but not limited to: the intended population, the overall goal of the program, the activities associated with the program, and the program's length of stay. The five program categories are outlined on the below:

<b>Surveillance</b>	high risk, high needs	Often offense type/ offense level specific	Temp, Conditions, Deferred, Probation	Provide ongoing surveillance of juveniles at risk of re-offense	Surveillance or intensive supervision; no structured curriculum; <i>Specifically for electronic monitoring, home detention, and ISP</i>	1 day - 90 days+	Juvenile probation officers
