**AMENDMENT 1 TO CONTRACT NUMBER CON0001314**

The **Texas Juvenile Justice Department**, hereinafter “**TJJD**,” and **Apex Learning, Inc.**, a wholly-owned subsidiary of Edmentum Inc. hereinafter “**Service Provider or Contractor**,” acknowledge that they have previously entered into a contract for Online Education Curriculum for the period of **September 9, 2021**, through **August 31, 2024**.

Both parties wish to continue the relationship that exists without a lapse in services. Service Provider agrees to continue to provide services under the aforementioned existing contract, and the TJJD agrees to continue to use Service Provider’s services during the term of this contract.

Service Provider represents and warrants that the individual signing this Amendment is authorized to sign this document on behalf of Contractor and to bind Contractor under this Amendment.

The parties hereto agree to be bound by the terms of the existing contract and amendments, if any, agreeing that the current provisions, terms, and conditions shall remain in full force and effect up until the date of termination and to remain bound by any terms or requirements that survive contract termination.

Pursuant to **Exhibit C, Terms and Conditions, Article 12: Contract Amendment and Merger Clause**, the contract may be amended and to reflect the following revisions. Therefore, the parties agree to amend **Contract Number CON0001314** as follows:

1. The first paragraph of the preamble of the contract is deleted and replaced with the following:

“The **Texas Juvenile Justice Department**, hereinafter “**TJJD**,” and **Edmentum Inc., PO BOX 776725 Chicago, IL 60677-6725**, hereinafter “**Service Provider**”, entered into a contract for Online Education Curriculum for the period of **September 9, 2021**, through **August 31, 2024**.”
