**FITNESS FOR DUTY EVALUATION
AMENDMENT 2 TO CON0001318**

The **Texas Juvenile Justice Department**, hereinafter **TJJD**, and **Butler Psychological Group, PLLC**, [REDACTED], hereinafter **Service Provider**, acknowledge that they have previously entered into a contract for the provision of Fitness for Duty evaluation services for the period **August 1, 2021**, through **May 31, 2025**. This contract is identified as **CON0001318**.

Both parties wish to continue the relationship that exists without a lapse in services. Service Provider agrees to continue to provide services under the aforementioned existing contract, and TJJD agrees to continue to use Service Provider's services during the term of this contract.

Service Provider represents and warrants that the individual signing this Amendment is authorized to sign this document on behalf of Service Provider and to bind Service Provider under this Amendment.

The parties hereto agree to be bound by the terms of the existing contract and amendment, if any, agreeing that the current provisions, terms, and conditions shall remain in full force and effect up until the date of termination and to remain bound by any terms or requirements that survive contract termination.

Pursuant to **Exhibit C, Terms and Conditions, Article 13: Contract Amendment and Merger Clause of the solicitation**, the contract may be amended and to reflect the following revisions. Therefore, the parties agree to amend **Contract Number CON0001318** as follows:

1. **SECTION I: CONTRACT TERM.** This contract is being renewed for the final renewal of two renewals, renewing the contract term through **May 31, 2027**, therefore the paragraph now reads as follows:

"The contract term is effective **August 1, 2021, through May 31, 2027, with no more renewals remaining.**"
