

**HEALTH AND HUMAN SERVICES COMMISSION

AMENDMENT NO. 1**

The **HEALTH AND HUMAN SERVICES COMMISSION (“HHSC”)** and the **TEXAS JUVENILE JUSTICE DEPARTMENT (“TJJJ”)**, who are collectively referred to herein as the "Parties," to the contract for computer assisted legal and investigative research effective October 1, 2019, and denominated HHSC Contract No. HHSREV100001787 “Contract” and TJJJ Contract No. CON0001128, now desire to amend the Contract.

WHEREAS, the Parties desire to revise Section V, Reimbursement, Billing, and Payment to add reimbursement rates, and Section VI, Contract Period and Renewal to extend the term of the Contract.

NOW, THEREFORE, the Parties hereby amend and modify the Contract as follows:

1. **SECTION V**, of the Contract, **REIMBURSEMENT, BILLING, AND PAYMENT, Paragraph 5.1, Reimbursement Rate**, is hereby deleted in entirety and replaced with the following:


5.1 Reimbursement Rate. TJJJ shall reimburse HHSC for each TJJJ CALIR License allocated during the term of this Contract. The reimbursement rates are as follows:

- A. October 1, 2019 through September 30, 2020 - \$41.73 per license per month;
 - B. October 1, 2020 through September 30, 2021 - \$42.99 per license per month;
 - C. October 1, 2021 through September 30, 2022 - \$44.28 per license per month;
 - D. October 1, 2022 through September 30, 2023 - \$45.60 per license per month; and
 - E. October 1, 2023 through August 31, 2024 - \$46.97 per license per month.
2. **SECTION VI** of the Contract, **CONTRACT PERIOD AND RENEWAL**, is hereby amended to reflect a revised Expiration Date of August 31, 2024.
 3. This Amendment No. 1 shall be effective as of the date last signed below.
 4. Except as amended and modified by this Amendment No. 1, all terms and conditions of the Contract, as amended, shall remain in full force and effect.
 5. Any further revisions to the Contract shall be by written agreement of the Parties.
