**CONTRACT FOR PAROLE SUPERVISION AND SERVICES
AMENDMENT 1 to CONTRACT # CON0001523**

The Texas Juvenile Justice Department, hereinafter TJJJ, and the Jefferson County Juvenile Probation Department, 5326 Highway 69 South, Beaumont, Texas 77705, hereinafter **Service Provider**, acknowledge that they have previously entered into a contract for the provision of parole supervision and services to TJJJ youth for the period of **September 1, 2023**, through **August 31, 2025**, in the following counties: **Jefferson, Hardin, and Orange**. This contract is identified as **Contract Number CON0001523**.

Both parties wish to continue the relationship that exists without a lapse in services. Service Provider agrees to continue to provide services under the existing contract, and the TJJJ agrees to continue to use Service Provider's services during the term of this contract.

Service Provider represents and warrants that the individual signing this Amendment is authorized to sign this document on behalf of Service Provider and to bind Service Provider under this Amendment.

The parties hereto agree to be bound by the terms of the existing contract and amendments, if any, agreeing that the current provisions, terms, and conditions shall remain in full force and effect up until the date of termination and to remain bound by any terms or requirements that survive contract termination.

Pursuant to **ATTACHMENT 1 Terms and Conditions, Article 13: Contract Amendment and Merger Clause**, the contract may be amended and to reflect the following revisions. Therefore, the parties agree to amend **Contract Number CON0001523** as follows:

1. **Section I. Contract Term**, this contract is being renewed for the remaining two (2) years, extending the contract term through **August 31, 2027**, revised as follows:
"This contract is effective **September 1, 2023**, and shall remain in effect through **August 31, 2027**. Any renewals shall be at the same terms and conditions, including any approved changes."
2. **Section II. Service Provider, Exhibit A and Exhibit B** referenced in paragraph A., are removed and replaced with the **attached** revised **Exhibit A and Exhibit B**.
3. **Section IV. Notices** is revised as follows:
"Required written notices shall be addressed to the Texas Juvenile Justice Department, Office of Business Operations Department, Contracts at mailing address: P.O. Box 12757, Austin, Texas 78711-2757, or physical address: 1801 N Congress Ave., Ste. 13.1400, Austin, TX 78701, and the TJJJ District Office at Houston District Office, 3555 Timmons Lane, Suite 1535 Houston, Texas 77027 and to the Service Provider at 5326 Highway 69 South, Beaumont, Texas 77705."
5. **Attachment 1, V. TERMS AND CONDITIONS** are revised and attached hereto as **ATTACHMENT 1, TERMS AND CONDITIONS** and hereby incorporated by reference.
