The General Land Office (GLO) and The Texas Youth Commission-McLennan County State Juvenile Correctional Facility ID# 1746000161 (Receiving Agency), are parties to that certain Interagency Cooperation Contract No. 10-203-000-4098, entered into effective December 9, 2009, collectively referred to here as Contract.

Whereas, the parties now desire to modify the Contract;

Now therefore, the parties agree to amend the Contract by adding the following provision to the contract, which will immediately precede Section I, Term and Amount of the Contract, and constitute the second paragraph of said contract:

"Effective December 1, 2011, the powers and duties of the Texas Youth Commission will transfer to the Texas Juvenile Justice Department in accordance with Title 12 of the Human Resources Code. Thereafter, the rights and obligations of this Agreement shall bind and benefit the Texas Juvenile Justice Department."

Except as amended and modified herein, the terms and conditions of the Contract remain in full force and effect.


