The General Land Office (GLO) and Texas Juvenile Justice Department - McLennan County State Juvenile Correctional Facility (Receiving Agency), are parties to that certain Interagency Cooperation Contract No. 10-203-000-4098, entered into effective February 1, 2010, collectively referred to here as Contract.

Whereas, now desire to modify the contract to extend the term of the contract;

Now therefore, the parties agree to amend the Contract as follows:

1. Paragraph 1.01 is amended to read as follows:


Term: This contract shall be effective February 1, 2010 through August 31, 2013; **HOWEVER**, the Contract shall be extended for each subsequent biennium if the requisite funding is appropriated by the Texas Legislature for the GLO and Receiving Agency for such biennium.

It is agreed and understood that any extension of this contract beyond the current biennium is dependent upon the requisite funding being appropriated by the Texas Legislature for the GLO and Receiving Agency for such extended time period.

3.10 **Exhibit Amendments:** Exhibit A, Exhibit B, and Exhibit C of this Contract may be amended through the mutual agreement of the Parties by the execution of new exhibits signed and dated by both Parties. Receiving Agency hereby expressly grants authority to Mike Griffiths, Executive Director (INITIALED BY: MG; MG) to execute amendments to Exhibit A, Exhibit B, and Exhibit C.

Except as amended and modified herein, the terms and conditions of the Contract remain in full force and effect.
