



**INTERAGENCY COOPERATION CONTRACT
GLO CONTRACT NO. 10-203-000-4098
AMENDMENT NO. 6**

STATE OF TEXAS
COUNTY OF TRAVIS

The General Land Office (GLO) and Texas Juvenile Justice Department – McLennan County State Juvenile Correctional Facility ID# 1-45-350-7970-2 (Receiving Agency), are parties to that certain Interagency Cooperation Contract No. 10-203-000-4098, entered into effective February 1, 2010 collectively referred to here as Contract.

Now therefore, the parties agree to amend the Contract effective September 1, 2017 as follows:

1. Section 1.01 is deleted in its entirety and replaced with the following:

“1.01 **Term:** This contract shall be effective February 1, 2010, through August 31, 2019; **HOWEVER**, the Contract shall be extended for each subsequent biennium if the requisite funding is appropriated by the Texas Legislature for the GLO and Receiving Agency for such biennium.”

2. Exhibit B, Gas Consumption Per Month in MMBtu, is deleted in its entirety and replaced with the attached Exhibit B, Gas Consumption Per Month in MMBtu.

3. Section 3.10 is being deleted and replaced with the following:

“3.10 **Exhibit Amendments:** Exhibit A, Exhibit B, and Exhibit C of this Contract may be amended through the mutual agreement of the Parties by the execution of new exhibits signed and dated by both Parties. Receiving Agency hereby expressly grants authority to David Reilly, Executive Director (INITIALED BY: ) to execute amendments to Exhibit A, Exhibit B, and Exhibit C.”

4. Section 4.03, (ii) is being deleted in its entirety and replaced with the following language, “the product of the month’s actual Index Gas Volume(s) times the Index Gas Price, plus”
5. Section 4.03, (iii) is being deleted in its entirety, and subsequent clauses (iv) (v) and (vi) are renumbered (iii), (iv) and (v), respectively.

6. The following Section 7.12, Confidentiality, is added to the original Contract as follows:

“7.12 Confidentiality: The contents of this Contract and any information related to it are confidential, may be excepted from disclosure, and may not be released without the authorization of the General Land Office, a ruling from the Office of the Attorney General, or an order from a court to do so. Any request for disclosure of the contents of this Contract or any information related to it received by the Receiving Agency must be submitted to the Office of the Attorney General in accordance with Section 552.301 of the Texas Government Code. The General Land Office must be notified of the request in accordance with Section 552.305 of the Texas Government Code.”
