



**INTERAGENCY COOPERATION CONTRACT
GLO CONTRACT NO. 10-203-000-4098
AMENDMENT NO. 7**

The General Land Office (GLO) and Texas Juvenile Justice Department – McLennan County State Juvenile Correctional Facility ID# 1-45-350-7970-2 (Receiving Agency), are parties to that certain Interagency Cooperation Contract No. 10-203-000-4098, entered into effective February 1, 2010 collectively referred to here as Contract.

Now therefore, the parties agree to amend the Contract effective September 1, 2019 as follows:

1. Section 1.01 is deleted in its entirety and replaced with the following:

“1.01 Term: This contract shall be effective February 1, 2010, through August 31, 2021; **HOWEVER**, the Contract shall be extended for each subsequent biennium if the requisite funding is appropriated by the Texas Legislature for the GLO and Receiving Agency for such biennium.”

2. Exhibit A is deleted in its entirety and replaced with the attached Exhibit A.
3. Exhibit B, Gas Consumption Per Month in MMBtu, is deleted in its entirety and replaced with the attached Exhibit B, Gas Consumption Per Month in MMBtu.
4. Section 3.10 is being deleted and replaced with the following:


“3.10 Exhibit Amendments: Exhibit A, Exhibit B, and Exhibit C of this Contract may be amended through the mutual agreement of the Parties by the execution of new exhibits signed and dated by both Parties. Receiving Agency hereby expressly grants authority to Camille Cain, Executive Director (INITIALED BY: ) to execute amendments to Exhibit A, Exhibit B, and Exhibit C.”

Except as amended and modified herein, the terms and conditions of the Contract remain in full force and effect.


