AMENDMENT 1 TO CONTRACT NUMBER CON0001629

Texas Juvenile Justice Department, hereinafter "TJJD," and WorkQuest, 1011 East 53 ½ Street Austin, Texas, 78751, hereinafter "WorkQuest," which has assigned the performance of this contract to World Technical Services, Inc., hereinafter "Performing Party," acknowledge that they have previously entered into a contract for the provision of janitorial services at Evins Regional Juvenile Center, 3801 E. Monte Cristo Road, Edinburg, Texas 78541, for the period of September 1, 2024 through August 31, 2025. This contract is identified as Contract Number CON0001629.

The parties wish to continue the relationship that exists without a lapse in services. WorkQuest and Performing Party agree to continue to provide services under the aforementioned existing contract, and TJJD agrees to continue to use WorkQuest and Performing Party's services during the term of this contract.

WorkQuest and Performing Party represent and warrant that the individuals signing this Amendment are authorized to sign this document on behalf of WorkQuest and Performing Party and to bind WorkQuest and Performing Party under this Amendment.

The parties hereto agree to be bound by the terms of the existing contract and amendments, subject to the following changes:

Pursuant to **TERMS AND CONDITIONS, 13, Contract Amendment and Merger Clause**, the contract may be amended and to reflect the following revisions.

1. Pursuant to **Introduction**, delete name of **Evins Regional Juvenile Center** and replace it with **Evins State Juvenile Correctional Facility**.
2. Pursuant to **SECTION I, GENERAL TERMS, A. TERM**, TJJD is hereby exercising its first option under this contract to renew the contract term for an additional one (1) year period, from **September 1, 2025**, through **August 31, 2026**.
3. Pursuant to **Terms and Conditions**, delete **TJJD Terms and Conditions**, in its entirety, and replace it with revised **Terms and Conditions - Exhibit A**.
